### 1. Assistant Investigation Officer (Legal)

**Role:** To assess and investigate anti-competitive practices, providing quality legal analysis on cases, as well as conducting advocacy activities, undertaking research work, contributing to market studies and other such assignments

*Minimum requirements*: candidates should possess at least a bachelor's degree, from a recognised body, in Law or any equivalent qualifications acceptable to the Competition Commission and reckoning at least three years' post qualification work experience preferably in investigation/research work/assignment.

## 2. Assistant Investigation Officer (Economics)

#### 3. Finance Officer
